TOP SECTION

Only one Part A is used for each accident.

- 1 The pre-printed report number should match on all pages.
- 2 The roadway type and accident type are listed. (Multiple types may be checked.)
- 3 The time, date and location of the accident is included. (The state of Washington uses numbers for counties and cities. IN/OF indicates if the accident was inside or outside the city limits.)
- 4 The total number of units (vehicles, pedestrians and owners of damaged property) involved in the accident.

UNIT 1

This section is about the first vehicle (or unit) involved in the accident. (Unit 01 is always a motor vehicle or pedalcycle, such as a bicycle. But it is not necessarily the vehicle at fault.)

- 5 Type of unit (motor vehicle or pedalcycle).
- 6 The damage threshold is checked if total damage is more than \$1,000.
- 7 The name and contact information of the operator. (This may be filled in with "unknown" if this information is not available, such as in the case of a hit and run accident.)
- 8 License information (include CDL information, if applicable).
- 9 The "On Duty" box is checked if the accident involved an on-duty law enforcement officer or firefighter.
- 10 The restraint code indicates whether seatbelts were used.
- 11 For motorcycle and bicycle accidents, the helmet use code indicates if a helmet was worn at the time of the crash.
- 12 Injury coding indicates the type and severity of any injuries.
- 13 Vehicle Information: This includes the license plate, registration, contact information and insurance information of the vehicle owner.
- 14 A diagram indicates where the vehicle sustained damage.

UNIT 2

This section is about the second vehicle (or unit) involved in the accident. (Unit 02 may be a vehicle, pedestrian or owner or property damaged in the accident.)

- 15 The information is identical to that in Unit 01, but there may be some differences if the unit is a pedestrian or property owner.
- 16 The responding police officer prints his or her name and badge number.
- 17 Additional units may be identified if more than two vehicles were involved in the accident.

PART B

All accidents will include at least one Part B.

- 18 The pre-printed report number should match on all pages.
- 19 An officer may use Part B to correct a previous page, and will check the "correction" box.
- 20 This lists passengers and witnesses involved in the accident. It also includes their contact and demographic information. Their seating position, airbag use, restraint use, helmet use and injury coding will also be listed.
- 21 A diagram indicates what happened in the accident.
- 22 The narrative section describes what happened. Additional pages may be used.
- 23 The responding officer will sign and date the form, which will also indicate when police were dispatched to the scene and when they arrived.
